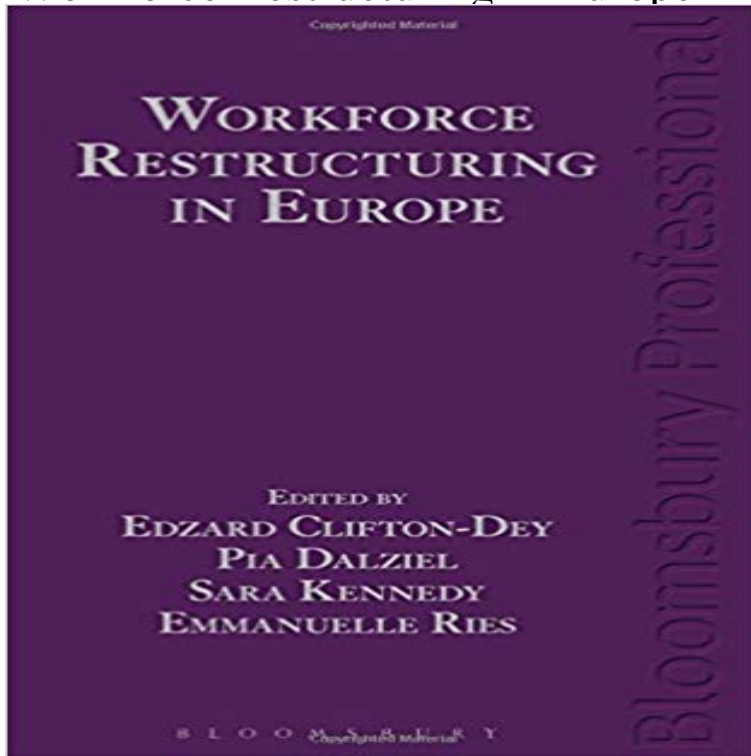


## Workforce Restructuring in Europe

Individual State chapters aid practical comparison. These scenarios are examined across the 28 EU Member States, plus Norway and Switzerland, each in their own chapter, to allow for practical comparison across various jurisdictions. An introductory chapter on EU minimum standards helps the reader to place each country within the context of EU law. Each chapter follows the same template to allow for easy comprehension of how to approach the same issue across borders. They cover: employment status \* process for individual redundancies \* process for collective redundancies \* Works Council and consultation requirements \* employment implications of business transfers \* unilateral and mutually agreed changes to terms and conditions of employment \* local status of legislation and case law. To keep the book user-friendly, legislation and case law are addressed in such a way that presents the current local primary and secondary status of each, without excessive use of unnecessary citations.
